Hello Everyone,

As you may have seen, the Victorian Government has announced **new COVID regulations to come into effect from 6pm on Friday October 29**. The attached document gives details for gatherings of various kinds. Here I simply offer a summary of the provisions that relate to **gatherings in churches**.

**When vaccination status is unknown**, the new government regulations will permit gatherings of up to **30 people** for religious ceremonies, with 1 person per 4 square metres. I ask that each parish have at least one Mass each week with this limit of 30 people, so as to provide some access to Mass for those who, for various reasons, are not vaccinated.

For those who are **fully vaccinated or have a medical exemption**, the new government regulations will permit gatherings of up to **500 people** for religious ceremonies, with 1 person per 4 square metres. Vaccination status relates to those 16 years of age and older.

For weddings, when vaccination status is unknown, the figure is 30 people plus the marrying couple and those necessary to conduct the wedding. For those fully vaccinated or with a medical exemption, the figure is 500 people as above.

For funerals, when vaccination status is unknown, the figure is 30 people plus those necessary to conduct the funeral. For those fully vaccinated or with a medical exemption, the figure is 500 people as above.

Thank you for supporting one another through these trying times. I offer special thanks to those who have assisted with gatherings in our churches over these past 18 months - those who have taken bookings for Masses, those who have helped us register as we have arrived at church, those who have done the extra cleaning throughout the pandemic. I ask you to continue to be patient as we negotiate the time ahead. Especially I ask you to be patient if you attend a gathering where we need to check vaccination status. Remember, those checking have not made the regulations. They are simply helping us to have as many people as possible attend Mass within the constraints of the government regulations.

# Victoria's Roadmap: Delivering the National Plan

## Summary of proposed restriction levels - Regional Victoria

Note 1: The settings below are indicative only and subject to change. All changes to the Chief Health Officer's Directions are based on public health advice (including epidemiological evidence) and legal advice (including as to compatibility with the Charter for Human Rights and Responsibilities) at the relevant time, in light of the specific risks to public health and changes/measures proposed. All directions must be reasonably necessary to protect public health and the Chief Health Officer (or delegate) must act in a way that is compatible with the Charter for Human Rights and Responsibilities.

Note 2: Cleaning, signage, record keeping, and other COVIDSafe requirements for work premises continue to apply for all venues and facilities with onsite operations as per Workplace Directions and Workplace (Additional Industry Obligations) Directions. Density quotients (DQ) apply to all venues and spaces that are accessible to the public.

Note 3: All proposed easings from 80% fully vaccinated (indicatively 5 November) are dependent on the ability for venues and employers to confirm vaccination status of patrons and employees, respectively.
