Scope

The Australian Catholic Bishops Conference *Laudato si'* Action Plan encompasses the operations of entities under the direct governance of the Conference, that is:

- the Plenary Meeting;
- the Permanent Committee;
- the Episcopal Commissions and Episcopal Panels; and
- the General Secretariat.

It does not encompass agencies of the Conference which exercise their own governance.

The Conference Laudato si' Action Plan shall incorporate:

- longstanding commitments of the Conference which are consistent with Laudato si';
- initiatives undertaken since 2015 that respond to Laudato si'; and
- new initiatives undertaken following the Conference's commitment in 2021 to develop a *Laudato si'*Action Plan

Coordination

The Conference's Social Justice Statement 2021-22, Cry of the Earth, Cry of the Poor, committed the Conference to continuing its well-established efforts to respond to Laudato si' by developing a Laudato si' Action Plan.

The Bishops Commission for Social Justice, Mission and Service has been given oversight of the Action Plan, each iteration of which requires the approval of the Conference. The Commission will be assisted by a *Laudato si'* Working Group, established to provide for collaboration between the Commission and the Conference.

The Office for Justice, Ecology and Peace has been tasked with coordinating the development and response of the Conference's Laudato Si' Action Plan, in consultation with the General Secretariat.

Timing

The Conference has been responding to parts of *Laudato si'* since 2015. The Conference's Action Plan will be developed initially for the first two years of the Conference's participation, and then for the remaining five years.

Organisation of Plan

Several actions could logically sit under more than one Laudato Si' Goal. Their placement within this document reflects the organization of material within the Laudato Si' Action Platform.

Costs

Costs for the first two years will be met within current budget allocations. As the seven-year rolling plan is developed, additional costs will be submitted for approval via the standard budget process.
